The **Specialist Dementia Care Program (SDCP)** is a national initiative designed to provide **high-quality, restraint-free dementia care** in a dementia-friendly setting. The program aims to:

- Stabilise or reduce behavioural and psychological symptoms of dementia within an average of 12 months.
- **Transition older people** into less intensive care settings once SDCP care is no longer required.
- **Collaborate** with state and territory government services, Dementia Support Australia, and Severe Behaviour Response Teams.
- Enhance quality of life for people living with very severe dementia behaviours.

# **Key Responsibilities**

As the Nurse Unit Manager, you will:

- Lead the **operational and clinical management** of the SDCP unit in alignment with MLH policies and procedures.
- Ensure **safe**, **high-quality**, **and evidence-based nursing care** in accordance with the Australian Nursing Council (ANC) national competency standards.
- Provide clinical leadership and mentorship to nursing and care staff.
- Promote **person-centred**, **goal-oriented care**, focusing on rehabilitation and capability-building to support older persons in transitioning out of SDCP.
- Work closely with the **MLH Management team** to maintain quality improvement processes and compliance with relevant statutory requirements.
- Supervise and collaborate with **healthcare professionals**, **older people**, **and carers** to deliver best-practice care.
- Maintain **effective communication** across teams and stakeholders, including older people and their families.
- Oversee risk management and infection control in line with MLH policies.
- Participate in team meetings, staff training, and professional development under the National Dementia Education and Training Standards Framework.
- Monitor and manage **staff performance**, ensuring a supportive, high-functioning work environment.
